- Incentives earned weekly











SJC Summit & Youth Portfolio

Nucor, the largest steel company in the U.S., announced its plans to build a 256,000-square-foot micro-mill on approximately 440 acres in Frostproof. Polk County competed with South Carolina for the \$240 million project which will employ 250.

Nucor Steel Florida stated that local and state incentives, as well as logistics and the availability of skilled labor, were key decision drivers for locating to Florida. Nucor is headquartered in Charlotte, North Carolina and employs more than 24,000 nationwide.





