- Pilot partners CareerSource Northeast Florida and CareerSource Broward.





Pillar I: Alignment and Consolidation

Completed by June 30, 2024:

- New governance determined and in place across impacted local workforce development boards (LWDBs) including appointment of new board of directors.
- Finalized interlocal agreements, consortiums, and 501(c)(3) completed for realigned or consolidated boards.
- Designate Fiscal Agent and Administrative Entity.
- Operational transition completed for all impacted boards, or well underway.

Pillar II: System-Wide Improvements

Completed by June 30, 2024:

- □ Significant improvements applied operationally and in practice across the system.
- Backlog and plan of action for additional improvements.

Pillar III: Regional Planning

Completed by June 30, 2024:


- ☐ At least two regional planning areas identified, structured, and compliant with regional planning requirements.
- Plan in place for remaining regional planning areas to be created.

Key Objectives

- 1. Reduce local workforce development boards from 24 to 21.
- Implement system-wide
- improvements and consistent compliance models across LWDBs.
- 3. Create new regional planning areas, consisting of at least two contiguous LWBDs, that comply with Workforce Innovation Opportunity Act (WIOA).

Board staff are concerned with **retaining their positions** and **benefits** after consolidation.





Economic Update


- Florida's Unemployment Rate
 - 2.7% in August 2023
 - 34th consecutive month below national unemployment rate of 3.8%
- Labor force grew by 306,000 jobs over the year
 - Private sector grew by 244,600 jobs (2.9% over the last year)
- Population Growth
 - Remains 1.9% over the year
- 70.8 million visitors as of Q2 2023
 - Increased by 1.3% over the year





Hurricane Idalia Recovery Efforts

- Disaster Unemployment Assistance (DUA) activated on 09/03
 - Nearly 400 claims have been filed
- Emergency Bridge Loan activated 09/11
- Business Damage Assessment Surveys
 - 640 surveys have been completed as of 09/15



FloridaCommerce Award

- FloridaCommerce announces more than \$25 million available for Florida's rural communities

 Governor DeSantis announces more than \$1.6 million to Florida's mall businesses impacted by Hurricane Idalia through Small Business Emergency Bridge Loan Program
- FloridaCommerce awards more than \$184,000 for economic development planning through the Competitive Florida Partnership Program
- FloridaCommerce Awards \$1.2 million for community planning projects through Community Planning Technical Assistance Grant Program
- FloridaCommerce announces \$50 million available through the Local Government Emergency Revolving Bridge Loan Program
- Governor DeSantis announces more than \$187 million in awards for communities impacted by Hurricane Sally
- Governor DeSantis awards more than \$247 million through the Broadband Infrastructure Program
- Governor DeSantis announces more than \$13.1 million to the city of Sanibel through the Local Government Emergency Bridge Loan Program
- Governor DeSantis announces more than 2,265 bonuses awarded to New Law Enforcement Recruits in the first year of the program
- FloridaCommerce announces \$75 million available through the Florida Job Growth Grant Fund
- Governor DeSantis announces Hometown Heroes Program has provided \$100 million in down payment assistance to Florida's hometown workers
