Chair Katie Crofoot called the meeting to order at 10 a.m.

III. CHAIR'S WELCOME AND REMARKS

Introduction Of Committee Appointee, Dr. Christopher Constantine

Chair Crofoot welcomed new Committee member, Dr. Christopher Constantine. Dr. Constantine introduced himself.

Chair Crofoot described action on an appeal filed May 26, 2023.

Chair Crofoot described the meeting agenda.

IV. CONSENT AGENDA

Revisions to the Credentials Review Committee Charter

Chair Crofoot described updates to the Credentials Review Committee Charter required by Senate Bill 240.

V. ACTION ITEMS

Chair Crofoot introduced CareerSource Florida Senior Vice President for Workforce Program Development, Dan McGrew, to present the Action Items.

ACTION ITEM 1

Additions to the 2023-2024 Master Credentials List

Mr. McGrew described credential applications received including Career and Professional Education Act certifications. Each credential was reviewed by a committee including members of the Florida Department of Commerce (FloridaCommerce), the Florida Department of Education, and CareerSource Florida. This review group recommended the approval of one credential that met the requirements of the Framework of Quality.

Approve the addition of one credential to the 2023-2024 Master Credentials List and send this recommendation to the CareerSource Florida Board of Directors for delivery to the State Board of Education.

Approve technical revisions to the Master Credentials List by the Florida Department of Education, as needed, without adding or removing any credentials not explicitly described in the Action Item.

ACTION ITEM 2

Revisions to the Framework of Quality

CareerSource Florida Senior Vice President for Workforce Program Development, Dan McGrew, presented an overview of an Action Item on revisions to the Framework of Quality approved by the Credentials Review Committee. Revisions were needed due to changes in law and updated labor market data. A summary of the revisions is in the Action Item.

Approve the updated Framework of Quality, which will determine inclusion on the Master Credentials List for the state of Florida for applications received after July 1, 2023.

Chair Crofoot called for a vote to approve the Action Item.

The consent item passed unanimously. There were no comments.

VI. INCORPORATING AGRICULTURE CREDENTIALS

Chair Crofoot described the importance of including agricultural credentials on the Master Credentials List and invited Jaime Jerrels, Director of Strategic Initiatives with the Florida Department of Agriculture and Consumer Services to present on the process developed to include Agriculture Credentials on the Master Credentials List.

Director Jerrels noted the importance of agriculture credentials and that agriculture is the number two driver of Florida's economy. Agriculture credentials that do not automatically meet wage and demand requirements in the Framework of Quality established by the Credentials Review Committee will be submitted directly to the Florida Department of Agriculture and Consumer Services for consideration to be included on the Master Credentials List. Confirmation of receipt will be sent to submitters. The Department will consult with the University of Florida Institute of Food and Agricultural Sciences and Florida Agricultural and Mechanical University to review the credentials for demand. The Department of Education will review eligibility. The Florida Department of Commerce will review standard occupation code linkages. Evaluation results will be sent to CareerSource Florida. Credentials will be presented to the Credentials Review Committee for consideration. CareerSource Florida will notify applicants of the Committee's decisions.

Chair Crofoot called for comments from the Committee. Mike Biskie was recognized. Mr. Biskie commended Director Jerrels and the Committee for ensuring a process was in place to consider agriculture credentials for addition to the Master Credentials List.

VII. ACTION ITEM 3

Process for Department of Agriculture and Consumer Services Submission of Credentials to the Credentials Review Committee.

CareerSource Florida Senior Vice President for Workforce Program Development, Dan McGrew, presented Action Item 3.

Approve the Florida Department of Agriculture and Consumer Services proposed process for submitting credentials for consideration to the Credentials Review Committee.

Chair Crofoot called for a vote to approve the Action Item.

The consent item passed unanimously. There were no comments.

Chair Crofoot directed CareerSource Florida staff to add information about the process for adding agricultural credentials to the Credentials Review Committee website.

VIII. PREVIEW OF THE 2024-2025 MASTER CREDENTIALS LIST

Chair Crofoot invited CareerSource Florida Senior Vice President for Workforce Program Development, Dan McGrew, to present to the committee a preview of the 2024-2025 Master Credentials List.

Mr. McGrew presented what the updated Master Credentials List will look like after labor market information was updated. There are 2,108 credentials on the Master Credentials List. 416 of those credentials were identified as having provisional status because they do not meet wage and/or demand criteria. 106 credentials were provisional under the previous criteria and now meet the wage and demand requirements of the Framework of Quality. The next step for the 2024-25 Master Credentials List is for new applications to be received through September 30, 2023, and evaluated in the fall for presentation at the February Credentials Review Committee meeting.

Chair Crofoot opened the meeting up for questions. There were no comments.

IX. LIGHTCAST CREDENTIAL REVIEW AND ANALYSIS FINAL REPORT

Chair Crofoot reminded the Committee that Matthew Walsh with Labor Market Analytics Company, Lightcast, provided a status update on contracted research analysis at the previous meeting. The final report from Lightcast was provided to CareerSource Florida.

Chair Crofoot invited CareerSource Florida Senior Director for Workforce Program Development, Adam Briggs, to present on the Lighcast Credential Review and Analysis.

Senior Director Briggs described the report by Lightcast and identified specific sections of the report published on the Credentials Review Committee website.

Chair Crofoot asked the Committee if there were any questions for Dr. Briggs. James Taylor was recognized and asked if a search feature can be incorporated to identify specific credentials within an occupational field making the tool more functional for industry. Dr. Briggs responded.

X. UPDATE ON ENHANCEMENTS TO THE MASTER CREDENTIALS LIST APPLICATION PROCESS

Chair Crofoot recognized CareerSource Florida Senior Program Analyst for Workforce Program Development, Jackie Barreiros, to present an update on enhancements to the Master Credentials List Application Process.

Ms. Barreiros provided information on enhancements to the application process including a fast-track approach to submit additional information for review and updated technical assistance documents posted online.

Chair Crofoot asked if there were any questions. Dr. Constantine was recognized and asked about how industry specific information is received and reviewed.

CareerSource Florida Senior Director, Adam Briggs, responded providing information on wage and demand requirements and how applicants can identify emerging industries to which credentials are linked.

Ms. Barreiros identified application requirement for endorsement letters.

Chair Crofoot described challenges in identifying emerging industries and recommendations on emerging industries and demand can be brought to the Committee.

Chair Crofoot recognized Committee member James Taylor.

Chair Crofoot directed staff to explore recommendations for identifying emerging industries. Chair asked if there are any further questions.

XI. APPLICATION TIMELINE FOR CAREER AND PROFESSIONAL EDUCATION (CAPE) FUNDING FOR THE 2024-2025 SCHOOL YEAR

Chair Crofoot recognized Florida Department of Education Vice Chancellor for Career and Adult Education, Tara Goodman, to provide an update on the Career

and Professional Education Funding application timeline for the 2024-2025 school year.

Vice Chancellor Goodman explained that applications will be accepted through September 30, 2023. Applications will be reviewed by the review team for CAPE eligibility requirements and Framework of Quality. Results of evaluations will be brought to the Credentials Review Committee at its February 2024 meeting. The 2024-2025 Master Credentials List will be used to identify credentials for the 2024-2025 CAPE Industry Certification Funding List. The list is supplemented with Digital Tool Certificates. A final list is developed and sent to the State Board of Education for approval in August 2024.

Chair Crofoot asks if there are any questions for the Vice Chancellor. There are no questions.

XII. OPEN DISCUSSION AND PUBLIC COMMENT

Chair Crofoot opens the meeting up for discussion and public comment. There are no comments from members or the public. There are no comments in the chat.

XIII. CHAIR'S CLOSING REMARKS

Chair Crofoot gave closing remarks on updated labor market information and that the Committee will meet next in December or November. The Chair thanked the Committee for their time and reminded them of upcoming CareerSource Florida meetings.

Action Item 1

ADDITIONS TO THE 2023-2024 MASTER CREDENTIALS LIST

The Reimagining Education and Career Help (REACH) Act amended Chapter 445.004, Florida Statutes, and requires that the Credentials Review Committee define "Credentials of Value" and make recommendations for these credentials to be added to a state-approved Master Credentials List. The Committee is also charged with establishing a process for quarterly review and approval of credential applications.

In December 2022, the Credentials Review Committee approved the definition for Credentials of Value and a Framework of Quality by which these credentials would be evaluated. This <u>Framework of Quality</u> is used to evaluate credentials for inclusion on the state-approved Master Credentials List.

In February 2022, an online application for credentials seeking inclusion on the Master Credentials List was made publicly available and the Committee established application deadlines supporting a quarterly review and approval of applications. 38 existing credentials that were not originally evaluated because no Standard Occupation Code was established, and nine newly offered credentials were evaluated since the last meeting. These credentials were evaluated using the Framework of Quality for consideration for the Master Credentials List.

A summary of the credentials evaluated is below:

- New Credentials
 - Eight non-degree credentials evaluated with three passing the Framework of Quality
 - One degree credential evaluated with zero passing the Framework of Quality
- Existing Credentials
 - 31 non-degree credentials evaluated with 14 passing the Framework of Quality and 14 not passing either the demand or wage criteria.
 - One degree credential evaluated and passed the Framework of Quality.

Evaluation of applications is conducted by an interagency team of subject matter experts from the Department of Commerce, Department of Education, and CareerSource Florida. Each credential is evaluated against the Framework of Quality approved by this

Committee and, if applicable, the eligibility requirements for CAPE funding established by the Department of Education.

If approved, the updated recommended additions to the 2023-2024 Master Credentials List will be sent to the CareerSource Florida Board of Directors for delivery to the State Board of Education.

Subsequent to this approval and prior to the State Board of Education meeting, there may arise the need for technical revisions to the list, such as additional certification names, availability of the certification, or code numbers that need to be revised.

FOR CONSIDERATION

- Approve the addition of 18 credentials of value to the 2023-2024 Master Credentials List with full approval and 14 additional credentials with provisional approval and send these recommendations to the CareerSource Florida Board of Directors for delivery to the State Board of Education.
- Approve technical revisions to the list by the Department of Education, as needed without adding or removing any credentials not explicitly described in this Action Item.
