Review Committee Appeals Process

- 15-Day Appeal Window: Applicants challenge deficiencies in writing to President/CEO of CareerSource Florida
- Interagency Review: Appeals evaluated by team from FloridaCommerce, Department of Education, and CareerSource Florida
- Board Review: CareerSource Florida Board of Directors assess appeals in board meetings

Tosa Python	CAPE Post-Secondary Funding eligibility	Board approved Expert level proficiency for post- secondary funding at Dec. 12 meeting.

Status Update on 2024 - 2025 Master Credentials List

2024-2025 Master Credentials List

- FL Statute 445.004 requires annual review of the Master Credentials List.
- Over 2,300 credentials currently being evaluated and include:
 - Current Master Credentials List
 - New credentials added to the credential inventory
 - Existing credentials in the credential inventory that were not added to the Master Credentials List
- Existing Master Credentials List credentials that do not meet the Framework of Quality will be tagged for removal on the 2025-2026 Master Credentials List.
- Credentials tagged for removal will have opportunities to establish local demand or credential sequencing to cure deficiencies in either demand or wage evaluations.



Next Steps

 Once the annual evaluation is complete and verified, the Credentials Review Committee will need to convene to approve the new 2024-2025 Master Credentials List.



Summary of Applications Received

- 38 credential applications received from July 1 September 30
 - Two applications submitted to the Department of Agriculture and Consumer Services via the new process
- A total of 8 credentials are being presented to add to the Master Credentials List.

Action Item

For Consideration:

- Approve the addition of 8 credentials to the Master Credentials
 List and send these recommendations to the CareerSource
 Florida Board of Directors for delivery to the State Board of
 Education.
- Approve technical revisions to the list by the Department of Education, as needed without adding or removing any credentials not explicitly described in this Action Item.



CAPE Industry Certification Funding List:

State Board of Education Approval Progress

Secondary (Grades 6-12) Funding

- Industry Certifications may be eligible for K-12 funding requests.
- FDOE has additional criteria for Florida Education Finance Program (FEFP) funding in its administrative rules.
- The FDOE will inform school districts of the spring request window timeline.
- Upon meeting CAPE list inclusion requirements for FEFP funding, certifications may be recommended for the next CAPE funding list adoption.



CAPE Industry Certification Funding List:

State Board of Education Approval Progress

Postsecondary

- Determination of funding eligibility is made during the CRC review process.
- FDOE will recommend the certification for the next CAPE list with postsecondary funding eligibility after the CRC adoption of the Master Credentials List.











- What are the wages associated with this occupation in my area?








Scenario 2: Employer with Occupations in Production

- What are the associated wages for these occupations?






