






#### Workforce Program Enrollment

## Policy Development Update

- Strategic Policy CareerSource Florida Emergency Response (new policy)
  - Facilitating development of local area emergency response plans.
  - Requiring identification of local dedicated points of contact for response needs.
- Administrative Policy 074 Individual Training Account (ITA)
   Expenditure Requirements and Waiver Request Process (revision of 2018 policy)
  - Seeking better understanding of reasons for waivers beyond sliding scale.
  - Redefining processes for requesting, reviewing, and approving waiver requests.
  - Exploring impacts of connecting ITA performance failure to board sanctions.



## Policy Development Update

- Administrative Policy 104 Sanctions for Local Workforce
   Development Boards' Failure to Meet Federal and State Standards
   (revision of 2020 policy)
  - Identifying which types of performance failure merit mention in this policy.
  - Defining which performance scenarios require creation of corrective action plans for the local board.
  - Ensuring inclusion of local board chairs and chief local elected officials in such discussions.


